This year is the 40th anniversary of the great March on Washington that led to the Voting Rights Act of 1965. This year we have observed brave Iraqis and Afghans risking their lives to run for office and to cast votes.

The #1 mission of LWV is to guarantee every citizen the right to vote and have it counted fairly.

The #2 mission is to influence elected officials to act "for the general welfare" rather than for "special interests".

This month we had the opportunity to act on #3: Thanks to urging by LWV Oregon, the legislature is holding public hearings around the state rather than only in Salem. Trish Bowcock testified before the House Land Use Committee, and Mickey Ketchum and I before the Joint Ways and Means Committee recently. Observers were at these meetings wearing LWVRV buttons, and also at the Elections Committee hearing.

Before I mount my bike and ride off into the sunset (actually, just shifting gears to chair the powerful, much-feared LWVRV NOMINATING COMMITTEE - something like Karl Rove's Job?), let me remind you:

The U.S. uses 25% of the world's resources, though we have less than 5% of the population;

We produce twice as much garbage, per capita, as the citizens of the other industrialized nations;

40% of our waterways are no longer fit for swimming and fishing;

And the average American gets fewer miles to the gallon than Henry Ford's 1908 Model T!

LWV has positions for addressing all these endemically ubiquitous inequities; so are we daunted? Are we down-hearted? Are we despairing? NOT YET!!

## April Membership Meeting Summary

Methamphetamine abuse crosses all socioeconomic barriers and is epidemic in Jackson County. April's general meeting presentations by Rita Sullivan, Director of OnTrack and Lt. Dewey Patton of JACKNET focused on the havoc this drug wrecks on society. "85% – 95% of property crimes in our area are related to methamphetamine cases," stated Ms. Sullivan. This highly addictive drug is easy to manufacture from materials that are readily available at many local stores. Treatment is the only long-term solution. Unfortunately, funding for treatment is being dramatically cut without regard to overall societal costs such as an increase in prison capacity, property crimes or emergency room treatments.

### ANNUAL MEETING - NEWS

The nominating committee report is included in this Voters Voice. Please bring both the annual meeting package and the nominating committee report to the meeting on May 12, 2005 at Eden Valley Orchards.

Eden Valley Orchards was chosen for listing on the National Register of Historic places on July 14, 2000. Our meeting will be at the beautiful Voorhies Mansion, located on 27 acres, the historic birthplace of the pear industry in the Rogue Valley. The original owner of the property, Joseph H. Stewart, established the first pear orchard between 1885 and 1898. Stewart is considered the patriarch of Southern Oregon's fruit



A prominent contemporary of Stewart's remarked, "Every fruit tree in Rogue River Valley will be a monument to his memory." Indeed, two dozen of the pioneer's original trees are still growing at Eden Valley Orchards.

At Eden Valley Orchards, another of Stewart's legacies remains. In continuous use by orchardists and their families since its completion in 1898, is a large Colonial Revival Style house that Stewart built. Named for the family who bought the property a year later and owned it for the next 87 years, the Voorhies Mansion has been the literal and figurative heart of Eden Valley orchards for over a century. Contributions to the community and gracious hospitality are hallmarks of the Voorhies era. They are traditions that continue. Preceding Stewart and Voorhies were several orchardist families with the present owners, longtime orchard family, Robert and Betty F. Root.

Since 1999, the Roots have done much to preserve the house and its distinctive landscape, and have opened the "mansion" to the public as part of an educational program for agricultural history. With a focus on agricultural heritage and education, Eden Valley Orchards is also emphasizing Oregon's reborn wine industry.

## GOOD NEWS ON TRANSPORTATION

- Fifteen new and renewed bicycle commuters were launched April 16 when BIKE FIRST presented them with state-of-the-art fully-equipped (lights, carriers, odometer, fenders and foolproof chain) Breezer bikes. Winners from Grants Pass to Ashland had written essays on how and why they would use the cycles. Line up with their new bikes and their children at the annual Bear Creek Greenway Gala, they pledged to record their odometer readings monthly to document the actual number of miles traveled that otherwise would have been in a car, enabling the RVRTD to actually document how much carbon WAS NOT put into the air. This is a requirement for state and federal matching funds.
- Sidewalks around schools in Medford are being built with funds from the SAFE SIDEWALKS FOR KIDS bond issue which you all helped to pass in November. Thanks especially to Vicki Keeney, who represented LWVRV on the committee.
