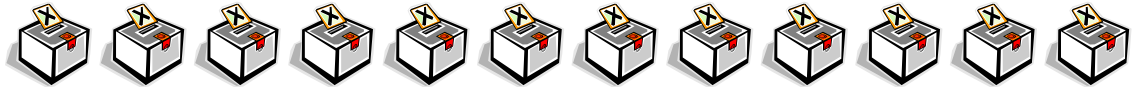

Most of you will remember our series of town hall meetings seeking citizen input on funding Jackson County. We learned a lot, including the fact we had much to learn about the way Jackson County government collects and spends money. Out of these meetings came a proposal to study how Jackson County collects revenue and targets expenditures. This league study kicks off with a presentation at our November General Meeting, a joint meeting with LWVA to be held in Ashland. County Administrator Danny Jordan will make a presentation on the basics of the county budgeting process. Our study emphasizes Public Safety and Health and Human Services. Sheriff Mike Winters will educate us on budgeting from the Sheriff's perspective. Health and Human Services Director Mark Orndorf will be out of town so Danny Jordan will also act as the H&HS representative. Come prepared to ask questions!

If you are interested in the Funding Jackson County study, plan to attend the November General Meeting. We will pass around a sign-up sheet and set the date for our first planning session. The League committee (comprised of those of you who sign-up) will decide what information we need and embark on the collection / interview process. We hope to emerge with a solid League position on Funding Jackson County Government. This will enable us to take action should we see something, either good or bad, that needs public input. If you can't make the meeting, but want to be part of the committee, call me.

In last month's newsletter, we sent a questionnaire. Twelve members answered the survey. We learned that most folks won't mind receiving the newsletter electronically and that lunch at the General Meetings, although nice, isn't a necessary amenity. Hands-down, the library was approved as a meeting venue.

After the first of the year, our goal is to begin sending the newsletter electronically to those of you who have email. If you don't have email, then you will continue to receive a hard copy.

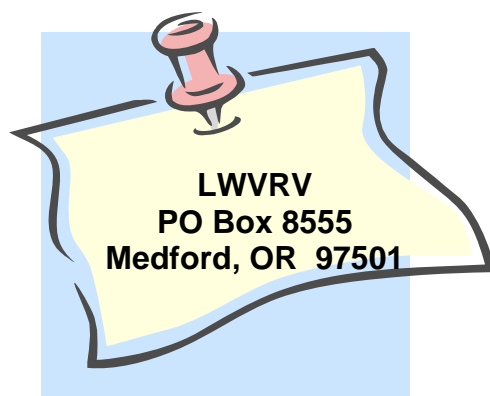

## GREAT DECISIONS

**Great Decisions** is a discussion group using a Briefing Book prepared by the Foreign Policy Association. Programs begin with a 25 minute DVD featuring an interview with two experts on each of the eight topics. The 2009 topics are: **U.S. and the Rising Powers, Afghanistan/Pakistan, Energy and the Global Economy, The Arctic, Egypt, Global Food Supply, Cuba After Castro, and Human Rights.**

## LANDUSE ACTION TAKEN

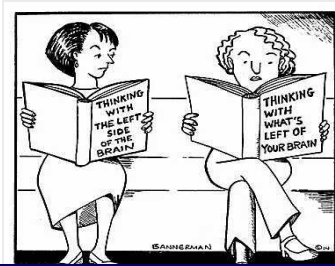
*LWVRV weighed in on two important land-use topics:*

1. The Big Look Committee Town Hall meeting was a big disappointment. The meeting, billed as an opportunity for citizens to give input, was held in a tiny venue. Many Rogue Valley citizens were turned away. LWVRV wrote the Chairman of the Big Look Committee and requested that they return to Medford to allow meaningful citizen input. Another meeting was held at South Medford High on October 20<sup>th</sup>. Unfortunately, publicity of this meeting was not widespread.
2. For some reason LCDC decided to schedule the Greater Bear Creek Regional Problem Solving Project (RPS) plan for consideration at their meeting in Prineville. LWVRV sent a letter expression concern with this decision (why not have the meeting here, where it counts?). We requested that any serious consideration regarding the adequacy of the RPS plan be delayed until the plan has been properly vetted by going through the appropriate and legally required local processes.

## LANDUSE IN JACKSON COUNTY

The Big Look Committee had their second hearing in Medford Monday Oct. 20 and I hope you had another chance to listen to a more reasonable testimony than in the first. The Task Force has received hundreds of comments from Oregonians urging them to strengthen existing safeguards while an independent research conducted for the Task Force show that the Oregon land use program is effective at controlling sprawl and supporting agriculture.

Unfortunately, the Task Force continues to advance ideas - such as the wholesale reclassification of rural land - that would undermine years of accomplishments. Rather, than be forward looking, The task force decided not to work on the well known connection between land use development patterns and global warming pollution from cars and trucks.

These shortcomings are a move in the wrong direction and it is up to to change their course. Everyone who took the time to attend a public workshop, write a letter, or send an email. Thank You!

The Task Force is now discussing draft legislation. These next few weeks are the last chance for you to submit comments before the proposals are final. It is best to send it by email to john.evans@state.or.us. We must prepare for global warming by reducing the amount Oregonians need to drive, we must strengthen Oregon's land use planning program to prepare for the challenges ahead. not weaken it.

# Women in Politics: Good News on the Horizon

Over 18 percent of parliamentarians worldwide are women, according to a recently released study by the United Nations Development Fund for Women[UNIFEM] -- an increase of seven percent over 1995, reports the New York Times of 9.19.08. A little too slow for my taste but still encouraging in view of the current stage of human development.

"We need to convince women that the only way to make a real change is to stop complaining and just be the owner of power" said Senator Cecilia Lopez Montano, Speaker of the opposition Liberal Party in Colombia.

To reach parity for women [ 40 to 60 percent elected to parliamentary seats] in developing countries, it will take until 2045. But I don't believe we need to accept that and be complacent about it. According to the study, Countries with reserve seats requirement quotas for women have done better than those without -- 19.3 percent versus 14.7 percent. For example, of the 22 countries with 30 percent women parliamentarians, 18 have quotas.

Recently, Rwanda became the first country in which women will hold the majority of seats [44 out of 80]. Perhaps genocide had something to do with it as it motivated women to get more involved politically during the country's reconstruction and recovery, observes the above-mentioned New York Times report. The UN study also found high correlation between the number of women elected and legislation related to women's issues from Day Care to Street Lighting. And where there were women candidates, women turned out in higher numbers to vote. All encouraging news!
