Brief Check In

Approval of December minutes. Approved as written

Treasurer's Report - Treasurer, Willie Bijon, reports PMP due. Treasury balance available on request.

LWVOR - Mary Sinclair reports LWVOR provides dues structure within state and budget committee needs to review. Continues with Coastal Study.

Water Study anticipated to be complete by May 2011

UN's Humanitarian Efforts in Haiti

On January 12, 2010 a 7.0 magnitude earthquake shook one of the poorest nations on earth which:

- ·claimed 222,570 lives and injured 300,572 others;
- ·destroyed 293,383 homes, and displaced 2.3 million one Haitian in four;
- ·wrought \$7.8 billion in damages, more than the country produced in a year; and
- · affected 3.5 million Haitians, including the entire population of Haiti's capital.

Among the dead were 102 UN personnel - the largest such loss of life in the UN's history. Some 16,000 Haitian government workers also died, and many others fled Haiti following the quake, cutting by one-third the government's work force.

It was "one of the largest natural catastrophes in recorded history," <u>Secretary-General Ban Ki-moon</u> said in a statement issued by his spokesman. "The world responded with much sympathy and assistance for the people of Haiti. The UN and international response was one of the largest of its kind ever mounted and continues to this day to help survivors of this tragedy."

<u>In the Aftermath...</u> The worldwide outpouring of generosity fueled an aid effort that saved many lives and by and large averted a follow-on humanitarian catastrophe that many had feared. Among the initiatives by the UN and its partners are:

UN peacekeepers from the UN Stabilization Mission in Haiti (MINUSTAH) helped maintain security as U.S. soldiers, emergency workers, aid professionals and fellow Haitians rushed help to the quake's survivors.

- · Approximately 1.5 million Haitians took shelter in camps. The crush of displaced people overwhelmed infrastructure whose inadequacy contributed to the rape of women and girls there, the spread of disease, and other problems that often plague overcrowded communities. These dominated the time of UN peacekeepers and aid workers alike.
- · A vaccination campaign in May 2010 reached nearly 1 million people, and the numbers of births in clinics or hospitals more than doubled. The World Health Organization (WHO) mobilized experts, distributed most of the medicines to combat disease, established a surveillance system to rapidly identify major illnesses such as meningitis, dengue and measles, and assisted in planning the reconstruction of 30 of the 47 hospitals destroyed by the quake.
- ---Since the <u>cholera epidemic</u> hit in October, WHO has trained more than 500 health professionals in cholera response. The death rate has dropped from 9 percent to 2.2 percent, but the situation remains a crisis. As of January 5, some 171,304 Haitians have contracted the disease, and 3,651 had died.
- --While UN and Haitian Government tests have shown no link to a contingent of UN peacekeepers who were blamed for the outbreak, Secretary-General Ban named top medical experts from four countries to an <u>independent panel</u>; among them is Harvard University's Daniele Lantagne.
- ·The UN World Food Program (WFP) has provided food to 1.1 million children who get lunch at school.

The UN and its partners are providing water to more than 1 million people every day, and food to more than 2 million people every month.

- · Half of Haiti's children were in school before the quake, and 95 percent have returned to their classes 2.2 million in all.
- \cdot 700,000 of the 1.5 million Haitians who once found shelter in makeshift camps have left. Of these, 100,000 have moved to new transitional shelters. Many who returned to their homes fear another quake and are living in their yards instead of their houses.

Among the 810,000 who remain in camps are those with the fewest resources and greatest needs, the International Organization for Migration (<u>IOM</u>) cautioned.

--- More than \$1 billion in aid has been disbursed - 72 percent of funds requested. The shortfall has hit management of camps for displaced people hardest.

Debris removal - and its recycling into building materials - continues, and 240,000 Haitians employed by UNDP and WFP already have cleared one million cubic meters.
